**For local businesses**, we are here to help you in preparing for an outbound FDI adventure or to collaborate on expanding locally through a JV or merger.

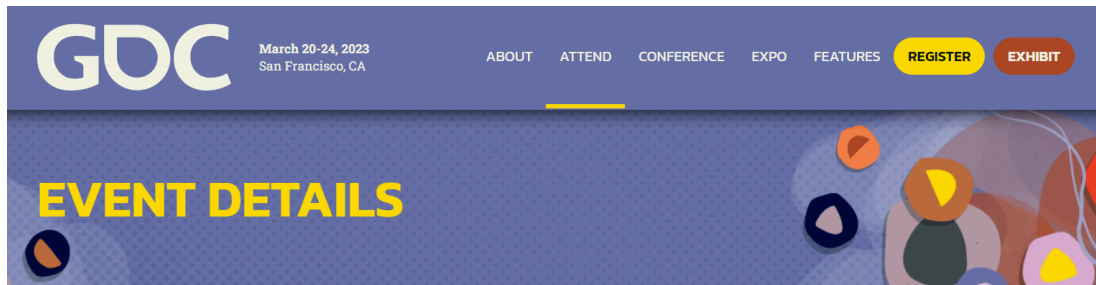


## **Events!**
