We continue to work with an Area Having Jurisdiction (AHJ) / unit of government in Texas to fine tune their upcoming offerings of their services to an international market.

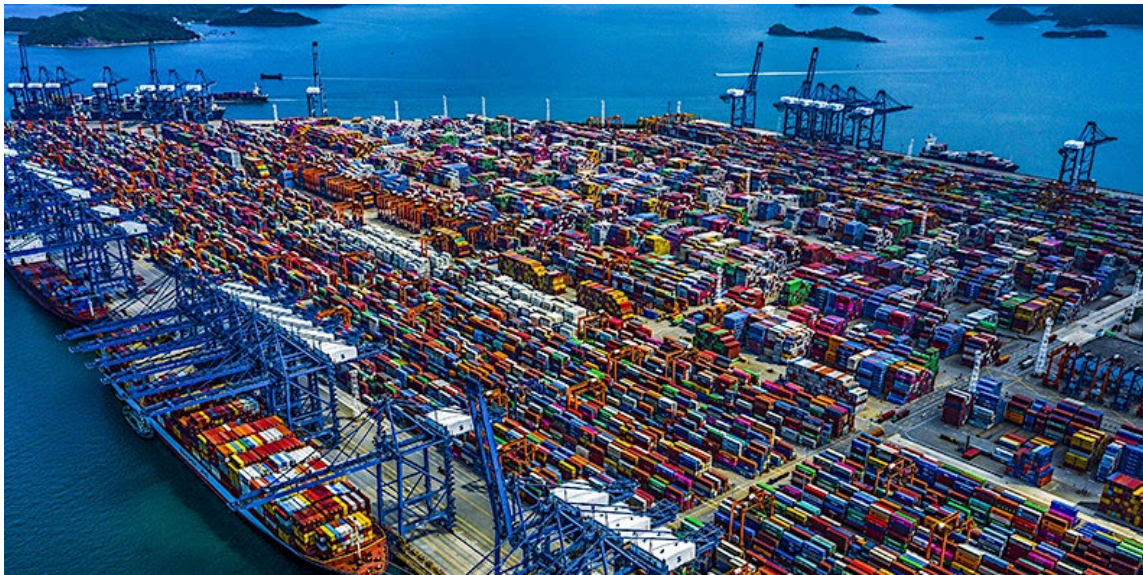

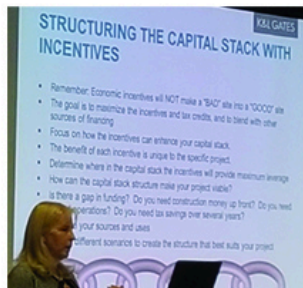
A private reception with Viktor Yushchenko, the former President of Ukraine:

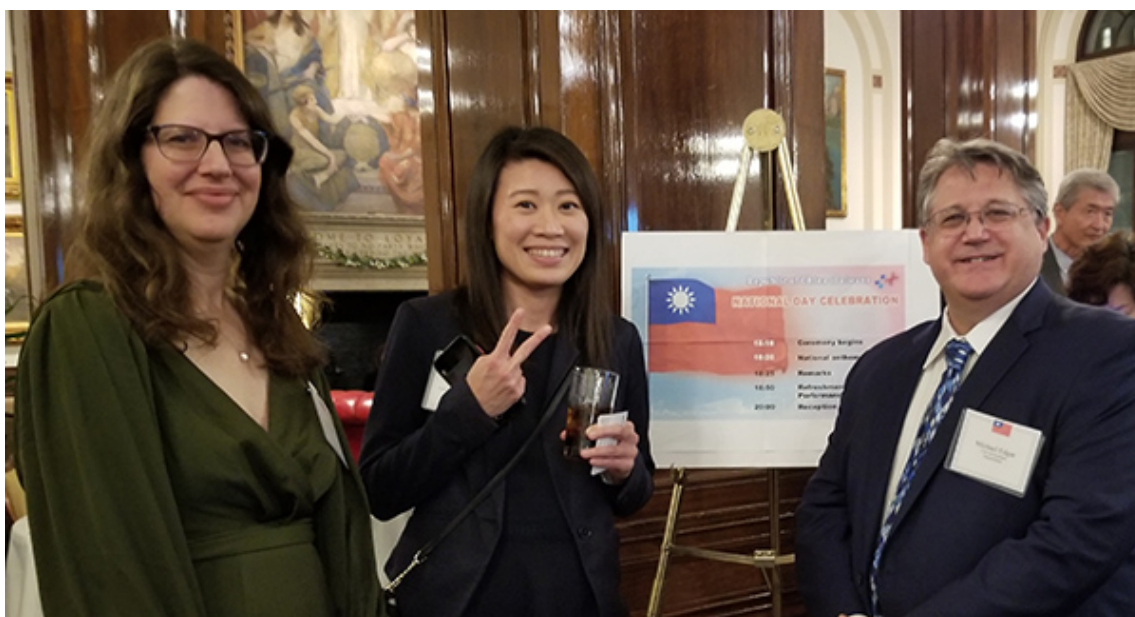
