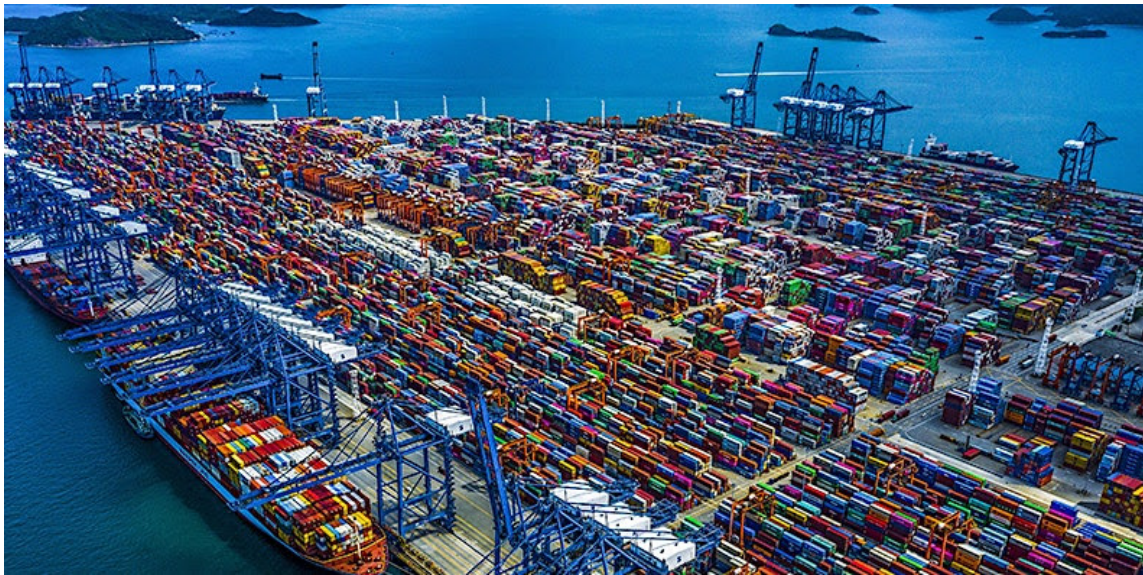

It was a discussion of how FTZ work. Foreign Trade Zones are a great way of bringing goods into the USA and deferring and transmuting tariffs to enhance the cash flow of U.S. businesses.

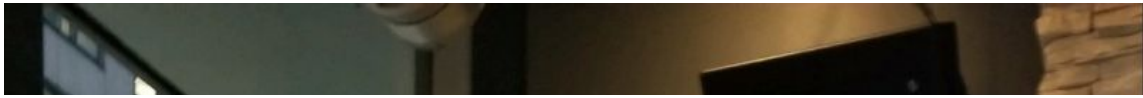

Building Business's Relationships Between Lithuania and the USA:



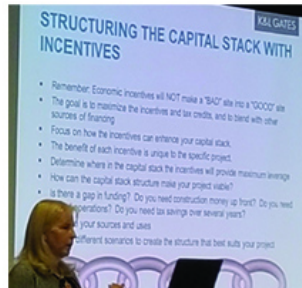
